#### **State Response to CDC Updated Guidance on Face Coverings**

Face covering <u>guidance</u> issued May 3, 2021 remains in effect at this time as State reviews the recent CDC guidance to determine what modifications may be needed in preparation for moving beyond the Blueprint for a Safer Economy on June 15, 2021.

<u>CDC Approves Pfizer Vaccine for ages 12-15:</u> On May 12, 2021, the Centers for Disease Control and Prevention (CDC) endorsed the safety and effectiveness of the Pfizer-BioNTech COVID-19 vaccine for ages 12 to 15 years, with a parent or guardian's consent. CDC Updates Guidance for Fully Vaccinated People: On May 13, 2021, the Centers for Disease Control and Prevention (CDC) revised its guidance for fully vaccinated individuals. Fully vaccinated begins two weeks after the second dose in a 2-dose series, or two weeks after a single-dose vaccine. According to this updated guidance, fully vaccinated persons no longer need to wear a mask or physically distance in any setting, except where required by federal, state, local, tribal, or territorial laws, rules, and regulations, including local business and workplace guidance.
