Project Title: Replacement of Well W076 in Bairs-Georges Wellfield

Project Location (include county): In the Bairs-Georges Wellfield, approximately 8.5 miles north of Lone Pine and 8 miles south of Independence.

Project Description: Well W076, in the Bairs-Georges Wellfield, has been used to supply the Los Angeles Aqueduct (LAA). It has failed and was shut down due to casing misalignment and excessive sand production. Los Angeles Department of Water and Power (LADWP) proposes to replace this well. Mitigation measures, which include pumping from the deep aquifer, have been included to minimize potential impacts to the groundwater and groundwater-dependent vegetation and wildlife.
