Project Title: Replacement of Well W390 in the Lone Pine Wellfield

Project Location (include county): East of Lone Pine in the NW 1/4 of Section 27, Township 15 South, Range 36 East in Inyo County, between East Locust Street to the north and East Inyo Street to the south.

Project Description: Well W390, in the Lone Pine Wellfield, has been drawing water at a diminished capacity due to excessive sand production. LADWP proposes to relocate and replace Well W390, to increase the well's irrigation efficiency and to maintain ground water supplies and recharge in the field that the well is irrigating.
