- 1 criteria for inclusion of a road into the County's
- 2 Maintained Mileage System?
- 3 A. Well, currently it needs to meet certain
- 4 design requirements and be considered by the Board
- 5 based on merits of the road and proposed use, et
- 6 cetera.
- 7 Q. So you said it needs to meet certain design
- 8 criteria?
- 9 A. Currently, yes.
- 10 Q. And when did -- that sounds like that may be a
- 11 new requirement?
- 12 A. Well, it's -- it's -- I guess it -- I don't
- 13 know that "new" is the proper term. It probably has
- 14 always had to meet certain standards but the standards
- 15 are modified over time. I couldn't tell you when the
- 16 current standards were adopted.
- 17 But as far as pavement width, design,
- 18 vertical/horizontal alignments, et cetera, that's
- 19 usually the criteria that, before we bring a road
- 20 before the Board for considerations for adoption, we
- 21 need to ensure that it meets that criteria.
- Q. Does the County's Maintained Mileage System
- 23 include both the primary and secondary roads?
- A. Would you define "primary" and "secondary"?
- 25 Q. Well, I was going to ask you to help me with

- 1 that.
- 2 A. We have paved and unpaved roads, if that's
- 3 what you're referring to. We have about 550 miles of
- 4 paved road and approximately an equal number of unpaved
- 5 roads within the County Maintained System.
- 6 Q. Look at, if you would, please, Resolution
- 7 Number 48-8, which is attached to Exhibit A-1 to your
- 8 declaration.
- 9 In the first "Whereas" clause, it says the
- 10 Board of Supervisors of the County of Inyo, State of
- 11 California, has adopted maps of the County primary road
- 12 system which also show the secondary roads of the
- 13 County road system.
- 14 So do those terms have meaning to you in that
- 15 context?
- 16 A. I would think the primary roads would be roads
- 17 of higher importance than the secondary road system.
- 18 In today's language, one would -- I would probably use
- 19 a term of a collector, major collector, for primary
- 20 roads and something less than that for secondary roads.
- 21 I think it's just a level of importance that they're
- 22 referring to.
- Q. If you would look at the next page, which
- 24 is -- of that attachment, so page number -- it's
- 25 Exhibit A-2. And we have Resolution Number 48-9 at

- 1 A. Well, there are cul-de-sac roads that go out
- 2 and end at locations. I think we do have roads similar
- 3 to that, yes. I think Last Chance Road is a very good
- 4 example of one that does.
- 5 Q. That does --
- 6 A. Goes out and ends.
- 7 Q. Okay. For the County to accept a road into
- 8 its Maintained System, does the road need to have been
- 9 a constructed road?
- 10 A. I -- again, I would rather -- I would need to
- 11 research that. But I believe that most roads that
- 12 were -- that are in our system are in existence and
- 13 were created in one form or another at one time.
- 14 Q. Do you know what the effect would be of a
- 15 resolution adopted by the County supervisors
- 16 identifying a road that doesn't exist anywhere?
- 17 A. Could you repeat that?
- 18 Q. Yeah.
- 19 Do you know what the effect would be of a
- 20 resolution adopted by the County supervisors that
- 21 identifies and purports to take into the County
- 22 Maintained System a road that doesn't -- does not in
- 23 fact exist on the ground?
- 24 A. Effect on what?
- Q. Would it be effective in terms of accepting

- 1 that identified road into the County Maintained System?
- 2 A. I believe the Board could adopt or could
- 3 accept dedication of right of way for a future road. I
- 4 don't know that it would be -- and I'm speaking in
- 5 today's terms -- we would not accept it into the
- 6 Maintained -- I do not believe we would accept it into
- 7 the Maintained System until it was constructed or
- 8 created. I don't know if that answers your question.
- 9 Q. Yeah. That's helpful.
- 10 Can you turn to the Road System Map for --
- 11 that includes the Last Chance Road North?
- 12 A. I think all of these -- all of these do.
- 13 Q. Okay. So we are looking at the map sheet from
- 14 the Road System Maps, which is dated 1993, and
- 15 indicates that it is sheet two of 23 and includes the
- 16 area around what we will call Last Chance Road North.
- 17 MR. ZUKOSKI: Can we go off the record for a
- 18 second?
- 19 (A discussion was held off the record.)
- 20 (Exhibit 12 was marked for Identification.)
- 21 MR. BERNARD: Back on.
- 22 Q. (BY MR. BERNARD) So, Mr. Pedersen, you now
- 23 have in front of you what has been marked as deposition
- 24 Exhibit 12, which is this same County Road System Map
- 25 from 1993, sheet two of 23 (sic). You now have a hard

- 1 legal question that I don't know that I'm prepared to
- 2 answer.
- From my perspective, what I look at as far as
- 4 Maintained Mileage is the road maps and the Road Tabs
- 5 with respect to what is identified and certified with
- 6 the State of California as the Maintained Mileage.
- 7 Q. The County Road Register -- we have the
- 8 original, this here on the table -- do you know when
- 9 this was prepared?
- 10 A. No, I do not.
- 11 Q. Do you know --
- 12 A. Originally prepared?
- 13 Q. Yes.
- A. No, I do not.
- 15 Q. Do you know if it was updated along the way
- 16 after it was originally prepared?
- 17 A. Well, apparently it was at some point, based
- 18 on the footnotes.
- 19 Q. Okay.
- 20 A. Or portions thereof.
- Q. Okay. So the footnote's referencing 1948
- 22 resolution.
- Okay. And with respect to Resolution 48-9 at
- 24 page A-2 of your declaration, I believe you said the
- 25 County does not have the map referenced in that

- 1 Q. Yeah, I believe you do. Let's see.
- 2 Paragraph seven. You say the USGS Last Chance
- 3 Mountain map from 1987 --
- 4 A. Uh-huh.
- 5 Q. -- right?
- 6 Okay. So is the County claiming a right of
- 7 way for the road as you've identified it on the ground
- 8 and as you believe it corresponds to the 1987 map?
- 9 A. Are we claiming a right of way? I think we're
- 10 claiming that it is a County-maintained road. And --
- 11 and I think there's a path that's definable.
- 12 Q. Okay. In the -- this lawsuit involves the
- 13 County's claim that it has a right of way for the road.
- 14 A. Uh-huh.
- 15 Q. So is the right of way that the County is
- 16 claiming a right of way for this road as you located it
- 17 on the ground?
- 18 A. Yes, I believe so.
- 19 Q. Okay. And you --
- 20 A. I don't know that I've seen that document.
- 21 But that's my understanding, that that is our claim,
- 22 that we have a road, we've maintained it in the past,
- 23 and it's part of our Maintained System.
- Q. Let's see. And back in paragraph six you say,
- 25 "The road is as reflected on Exhibit C to this

- 1 A. Yes.
- Q. Okay. As far as filing a claim with the
- 3 federal government or filing a lawsuit and making
- 4 claims on behalf of the County, who would be
- 5 responsible for doing that?
- 6 A. Well, the Board of Supervisors and yourself.
- 7 MR. KELLER: I don't have any other questions.
- 8 MR. BERNARD: Just a couple more.

- 10 EXAMINATION
- 11 BY MR. BERNARD:
- 12 Q. So you testified in response to questions from
- 13 Mr. Keller that the County can accept roads into its
- 14 system that may not be in existence; correct?
- 15 A. As long as there's provisions to construct
- 16 those roads through a development agreement-type
- 17 process.
- 18 Q. So the 1948 resolutions, they could
- 19 potentially have taken roads into the County system
- 20 that were not in existence; is that right?
- 21 A. I guess in 1948 anything is -- there's a
- 22 potential for that.
- 23 Q. And the Road Tabulations and the Road
- 24 Register, there could be roads reflected in those
- 25 documents that are not in existence; is that correct?

- 1 A. I assume that's a possibility. But I would
- 2 think, at this point, that they reflect roads that are
- 3 or were in existence or were at some point.
- Q. Well, we know that the register page that's
- 5 attached to your declaration as Exhibit B, I believe --
- 6 yes, B -- reflects a road that -- a road that is shown
- 7 in the register that -- the entirety of which does
- 8 not -- did not or does not exist, do we not?
- 9 A. Which road are you referring to?
- 10 Q. Yeah. Exhibit B to your declaration.
- 11 A. Uh-huh.
- 12 Q. The Road Register page for Last Chance Road
- 13 Number 2046.
- 14 A. Uh-huh.
- 15 Q. Okay. It indicates a road in length of 4.0
- 16 miles; correct?
- 17 A. Yes.
- 18 Q. Do you have any information that a road --
- 19 such a road ever existed?
- 20 A. No.
- Q. Okay. So, again, the Road Register could
- 22 reflect roads in the County system that don't in fact
- 23 physically exist; is that correct?
- A. That's possible. I don't know what existed in
- 25 1948 but it may not exist today.
