- ❖ Equity: Lynn Martin shared that the Q in LGBTQ stands for queer and questioning, the A is for asexual, and the + is for anything else. She reminded the group that, although inequities and stigma can make people feel more isolated, being in the LGBTQ community does not mean you have mental health issues.
- ❖ Covid19 Vaccination Clinics: Ms. Gillam asked about a vaccination clinic in Tecopa. Rose Colon shared that there had been a clinic in Death Valley and that there are also opportunities in Pahrump.

Dr. Zwier shared the following:

- ❖ As the JEDI committee, have continued our listening sessions
- ❖ We've had a listening session with representation from the Board of Sups and also one with a couple of members of the LGBTQ+ community. They shared a commitment to support young people. There's still much work to be done.

Strengths Based Model Case Management – presentation by Tim Toppass:

Tim Toppass shared an informative presentation on the Strengths Based Model of Case Management to the group. Ms. Gillam described it as being "thoughtful and powerful". His explanation of how, among other things, the Strengths Based model is "a celebration of personhood". This presentation was enthusiastically received by all.

Salvador Montanez shared the following:

• Wellness Center, in collaboration with other community agencies, is preparing a Covid19 Vaccination Opportunity at the Wellness Center.

Wellness Exercise by Chrystina Pope, LMFT:

Everyone in the group participated as Chrystina Pope led the group through a wellness exercise in soothing our nervous system – it was informative and included things one can simply do while at work or at home.
