# **Emergency Alert System (EAS) and Wireless Emergency Alerts (WEA) Nationwide Test – Important Information for Inyo County Residents**

In coordination with the Federal Communications Commission (FCC), the Federal Emergency Management Agency (FEMA) is set to conduct a nationwide test of the Emergency Alert System (EAS) and Wireless Emergency Alerts (WEA) this fall. This test is an essential step in ensuring the effectiveness of emergency communication systems during critical situations.

The national test is scheduled to take place on **Wednesday, October 4, beginning at approximately 11:20 a.m. PT.** This test will consist of two portions: the WEA test and the EAS test.

#### **Wireless Emergency Alerts (WEA) Test:**

During the WEA test, all consumer cell phones will receive a test message. This will be the third nationwide test and the second test specifically directed to all cellular devices. The test message will appear in either English or Spanish, based on the language settings of your wireless device. Please note that this test will only be initiated on compatible phones within range of an active cell tower and whose wireless provider participates in WEA.

For those whose main menu is set to English, the message on their phones will read: "THIS IS A TEST of the National Wireless Emergency Alert System. No action is needed." For phones with the main menu set to Spanish, the message will display: "ESTA ES UNA PRUEBA del Sistema Nacional de Alerta de Emergencia. No se necesita acción."

#### **Emergency Alert System (EAS) Test:**

The EAS portion of the test will be sent to radios and televisions, and it is the seventh nationwide EAS test. The EAS test is expected to last approximately one minute and will include a message similar to the regular monthly EAS test messages with which the public is familiar. The message will state: "This is a nationwide test of the Emergency Alert System, issued by the Federal Emergency Management Agency, covering the United States from 11:20 to 11:50 hours PT. This is only a test. No action is required by the public."

FEMA and the FCC are working closely with EAS participants, wireless providers, emergency managers, and other stakeholders to ensure that this test is conducted smoothly and to maximize the public safety value of the test. The purpose of this nationwide test is to ensure that these communication systems remain effective in alerting the public about emergencies, particularly those at the national level.

In the event that the October 4 test is postponed due to widespread severe weather or other significant events, the back-up testing date is set for Wednesday, October 11.

**Stay Informed with Code Red:**

In addition to the nationwide test, we encourage all Inyo County residents to sign up for Code Red, our local emergency notification system. Code Red allows us to send important alerts and notifications directly to your phone, ensuring that you stay informed about local emergencies and critical situations.
